Executive Summary on the Economic Impact of Health Care Sector


- ◆ One job created in the health care sector of Nuckolls County would lead to the creation of another 0.66 job in other sectors of the county's economy.
- ◆ One dollar of income earned in the health care sector of Nuckolls County would lead to another \$0.54 of income earned in other sectors of the county's economy.
- ◆ One dollar spent in the health care sector of Nuckolls County would lead to another \$0.81 spent in other sectors of the county's economy.
- ◆ The overall job creation due to health care (directly and indirectly) in Nuckolls County is estimated at 743 jobs, which accounts for 23.0% of the county's total employment.
- ◆ The overall income earned due to health care (directly and indirectly) in Nuckolls County is estimated at \$15.29 million, which accounts for 23.6% of the county's total income.
- ◆ The overall spending due to health care (directly and indirectly) in Nuckolls County is estimated at \$34.74 million, which accounts for 16.5% of the county's total economic output.



I. GEOGRAPHY

Nuckolls County is located near the southeast corner of Nebraska. The county has a total of 575 square miles with a population density of 8.8 people per square mile (Nebraska: 22.3 per square mile). The county seat of Nuckolls County is Nelson, Nebraska.





II. POPULATION

The population for Nuckolls County was 5,057 in 2000. The county has experienced a negative population change of -24.8% (compared to +9.0% statewide) during 1980-2000 (Figure 1). White (non-Hispanic) people still represented the great majority of county population in 2000 (99.2% vs. 89.6% statewide, Table 1). In addition, the county's population is older than the State's, with the elderly (aged 65+) representing 24.4% (compared to 13.6% statewide) of the population in 2000 (Table 2).



III. ECONOMIC IMPACT OF THE HEALTH CARE SECTOR

Retail Trade is the largest employer within Nuckolls County, followed by Agriculture, Health Care, Local and State Government, and Wholesale Trade. The Health Care sector of Nuckolls County includes one hospital, two nursing homes, two physician practices, three dentist practices, one optometry practice, one chiropractic practice, one mental health care practice, three retirement communities, one home health care service and two pharmacies.


- ◆ The 447 jobs in the health care sector of Nuckolls County have created (through a 1.66 multiplier) another 296 jobs in other sectors of the county's economy (Figure 2). Therefore, the combined effect represents 23.0% of the county's total employment (i.e., 743 out of 3,236 jobs).
- ◆ The \$9.92 million of income earned in the health care sector of Nuckolls County has created (through a 1.54 multiplier) another \$5.37 million of income in other sectors of the county's economy (Figure 3). Therefore, the combined effect represents 23.6% of the county's total income (i.e., \$15.29 million out of \$64.74 million).
- ◆ The \$19.16 million spent in the health care sector of Nuckolls County has created (through a 1.81 multiplier) another \$15.59 million of spending in other sectors of the county's economy (Figure 4). Therefore, the combined effect represents 16.5% of the county's total economic output (i.e., \$34.74 million out of \$210.66 million).

Figure 2. The Economic Impact of the Health Care Sector on Employment in Nuckolls County, Nebraska





Figure 4. The Impact of the Health Care Sector on Economic Output in Nuckolls County, Nebraska



IV. SOCIO-ECONOMIC INDICATORS


The per capita income of the county has increased since 1990 by 58.3% to \$15,608 in 2000 (compared to \$19,613 statewide), and the median household income of the county has increased since 1990 by 43.0% to \$28,958 in 2000 (compared to \$39,250 statewide) (Figure 5). Nuckolls County experienced a lower unemployment rate (2.4% vs. 3.5% statewide), while having a higher poverty rate (11.2% vs. 9.7% statewide) than the State in 2000 (Figure 6). Moreover, the county outperformed the State in two of the social indicators shown in Table 3, but had a higher percentage of residents aged 25 and older who did not graduate from high school and percentage of first births born to unmarried women, under 20, with less than a high school education.



V. HEALTH STATUS INDICATORS

The residents of Nuckolls County had a lower infant mortality rate and overall death rate, but had higher mortality rates for unintentional injury deaths and motor vehicle deaths compared with the State between 1997-2001 (Figure 7). Nuckolls County out-performed the State in one of the maternal and child health related indicators, shown in Figure 8, but had a higher low-weight birth rate, percentage of births to adolescents aged 10-17, and percentage of pregnant women who smoke. Among the top 5 leading causes of death of Nuckolls County residents, the county had a higher mortality rate than the State for cancer, cerebrovascular disease, and unintentional injuries (Figure 9). Nuckolls County had a higher hospitalization rate than the State for each of the top 5 leading causes of hospitalization of the county's residents between 1999-2000 (Figure 10).





Figure 8. Selected Maternal and Child Health Indicators, Nuckolls County and Nebraska, 1997-2001





**Defined as the proportion of inpatient hospital discharges to a population within clearly specified geographic boundaries, age adjusted per 100,000 population.



VI. HEALTH CARE PROFESSIONALS

Nuckolls County is federally designated as a medically underserved area. The State government has designated Nuckolls County as a health professional shortage area in the specialties of: family medicine, general surgery, internal medicine, pediatrics, OB/GYN, psychiatry, pharmacy, and occupational therapy.

Nuckolls County has a higher professional-to-population ratio than the State for physician assistants, registered nurses, occupational therapists, pharmacists, and EMS professionals, but a lower ratio for other health professionals shown in Figure 11.

VII. HOSPITAL AND LONG-TERM CARE BEDS

Table 4 shows that Nuckolls County’s hospital has a lower bed-to-population ratio than the State but a higher bed-to-population ratio for its long-term care industry. As a result, the need for hospital inpatient care (for the general public) may not be well met within the county.

Data Notes

The economic impact results presented in this report were obtained from a compilation of secondary data derived from the IMPLAN database, the U.S. Census Bureau's, *County Business Patterns 2000*, and primary data from a Community Health Systems Assessment Survey. The IMPLAN software analyzes county level data using an economic input-output model. However, certain information required for reporting health sector impact (e.g., total payroll for employees in a county owned nursing home) cannot be obtained from the IMPLAN database. When this happened, we used the information from the U.S. Census Bureau's, *County Business Patterns 2000*, and the Community Health System Assessment Survey that we conducted to calculate estimates and used them to report county specific health sector data.
